## Warranty

#### PENALTY CLAUSE

In case the bidder fails to supply the material within the time specified in the agreement, he shall without prejudice to any other right or remedy available under the law, pay compensation the amount calculated at the rates stipulated below or such smaller amount as the Director General may decide (whose decision in writing shall be final and binding).

The bidder shall pay an amount equal to 1% (One percent) of tendered value for every week or part of a week that the work remains uncommenced or unfinished after the expiry of the completion date. The entire amount of compensation to be paid under the provisions of the clause shall not exceed TEN percent of the value of the accepted Tender.

#### JURISDICTION

In the event of any disputes, difference or controversies, arising between the parties hereto, out of or in connection with terms and conditions of this order, or any action taken hereunder, the parties shall explore the possibilities for an amicable settlement. In case amicable settlement is not reached, such dispute, differences, controversies shall be settled by Arbitration.
